

**PUBLIC NOTICE**  
**LOUISIANA DEPARTMENT OF ENVIRONMENTAL QUALITY (LDEQ)**  
**CITY OF SPRINGHILL**  
**SPRINGHILL WASTEWATER TREATMENT PLANT**  
**DRAFT WATER DISCHARGE PERMIT**

The LDEQ, Office of Environmental Services, is accepting written comments on a draft Louisiana Pollutant Discharge Elimination System (LPDES) permit prepared for the City of Springhill, Springhill Wastewater Treatment Plant, P.O. Box 398, Springhill, LA 71075. The facility is located **at Highway 157 E and 7<sup>th</sup> St. SE, Springhill, Webster Parish**. Upon the effective date of the final permit, the LPDES permit shall replace the previously issued LPDES permit.

The principal discharge from this existing source is made into Little Crooked Creek, thence into Big Crooked Creek, thence into Dorcheat Bayou in Subsegment 100501 of the Red River Basin, waters of the state classified for primary contact recreation, secondary contact recreation, propagation of fish and wildlife, agriculture and outstanding natural resource waters. Under the SIC Code 4952, the applicant proposes to discharge treated sanitary wastewater from a publicly owned treatment works serving the City of Springhill.

During the preparation of this permit, it has been determined that the discharge will have no adverse impact on the existing uses of the receiving waterbody. As with any discharge, however, some change in existing water quality may occur.

Written comments, written requests for a public hearing or written requests for notification of the final decision regarding this permit action may be submitted to LDEQ, Public Participation Group, P.O. Box 4313, Baton Rouge, LA 70821-4313. **Written comments and/or written requests must be received by 12:30 p.m., Thursday, May 12, 2011.** Written comments will be considered prior to a final permit decision.

Information forwarded by email should follow the Statewide email policies. Attachments included with emails may be blocked due to restrictions on file size or type. For details check the following link, <http://doa.louisiana.gov/ocs/email/policies.htm>.

If LDEQ finds a significant degree of public interest, a public hearing will be held. LDEQ will send notification of the final permit decision to the applicant and to each person who has submitted written comments or a written request for notification of the final decision.

The application, draft permit and fact sheet are available for review at the LDEQ, Public Records Center, Room 127, 602 North 5<sup>th</sup> Street, Baton Rouge, LA. Viewing hours are from 8:00 a.m. to 4:30 p.m., Monday through Friday (except holidays). **The available information can also be accessed electronically on the Electronic Document Management System (EDMS) on the DEQ public website at [www.deq.louisiana.gov](http://www.deq.louisiana.gov).**
