# Pavement program selected to develop, deploy innovative asphalt technologies



Elie Hajj, associate professor in the Civil and Environmental Engineering Department, shows asphalt core samples being tested in one of the five Pavement Engineering and Science Program laboratories. Hajj is leading a new collaboration with the Federal Highway Administration to facilitate bringing innovative materials and techniques to state highway departments around the United States.

Making your commute more enjoyable with smooth pavement, and your tax dollars spent more efficiently on asphalt pavement maintenance, engineers around the country depend on the Federal Highway Administration for guidance on the most up-to-date best engineering and construction practices.

The Pavement Engineering and Science program at the University of Nevada, Reno was chosen for a prestigious project with the Federal Highway Administration to help them administer their program to stimulate, facilitate and expedite the deployment and rapid adoption of new and innovative technologies relating to the design, production, testing, control, construction and investigation of asphalt pavements.

The FHWA program will help agencies and contractors use the latest technologies in order to provide the best travel surface possible for the public. It's a five-year cooperative effort between the FHWA and the University to improve the quality and performance of asphalt pavements in the United States.

“With such a broad spectrum of areas, our entire team, including faculty and industry representatives we work with, can cover all of the innovations, trainings and laboratory work required by FHWA; we have a diversity of knowledge and we understand very well FHWA’s needs,” Elie Hajj, project lead and associate professor in the College of Engineering’s Civil and Environmental Department, said. “We’ll help them help state highway agencies in advancing and implementing new asphalt pavement technologies for improving their pavement system. We’re the right team, at the right time, on the right project for FHWA.”

The work plan addresses several innovative areas. The first task is to finalize the work plan, which includes: identifying gaps in technology; risk/benefit analysis of adopting new technologies; define target audience for advancing technologies; market summary – who needs technical training or who are end users; message development; barrier analysis; performance measures and outcomes tools for communicate

# Mobility Equity: Turning Theory into Reality

Social equity has become a hot-button topic. Equity refers to achieving justice for marginalized communities who have been left behind by ensuring that they have the resources they need to catch up. But how do you actually achieve equitable outcomes in such a challenging and complex field like transportation and mobility? And what does mobility equity look like in a time when people have more transportation options than ever before?

Uber, bike-share, scooter-share, and other mobility options represent exciting new ways to move around our cities. Yet these new options also represent ways that transportation inequities can be exacerbated. So if new mobility options are going to play a role in uplifting equity across our society, environment, and economy, we need to focus a lot more attention on developing these systems with equity at their core.

For us, mobility equity means much more than just having equal access to transportation or mobility options. Mobility equity also means maximizing

clean air benefits and economic opportunities, especially in low-income communities of color.

We put together a framework that lays out a mobility equity vision with three goals:

1. Increase access to affordable, efficient, safe, reliable mobility options
2. Reduce air pollution
3. Increase access to economic opportunities

To achieve mobility equity, these three goals must be the filter that we use to make decisions about what kinds of mobility options we should allow on our streets. We need interconnected solutions to address interconnected problems that our communities face. Mobility options should not only get people from A to B, they should also be a mechanism for creating pathways into opportunity and to guarantee that anyone regardless of income, race, or zip code can lead a happy and healthy life.

Three key steps to achieve mobility equity

1. Identify the mobility needs of the community.
2. Conduct an equity analysis to compare outcomes of various mobility options.

3. Place decision-making power in the hands of the local community.

Under what specific circumstances would the Mobility Equity Framework be most useful?

We see five potential ways to do this, although our Framework is adaptable to pretty much any projects or idea.

1. Are you conducting research on how to position equity in transportation planning and decision-making?

This framework lays out a process for how to prioritize equity and community engagement in transportation planning and decision making. The mobility equity analysis allows communities assess and compare transportation and mobility projects by their impacts on low-income communities of color.

2. Do you need equity scoring criteria for a project?

The mobility equity analysis provides 12 mobility equity indicators that can be used to determine how projects perform on equity and sustainability measures. The indicators and metrics cover a range of topics, from mobility to health

### Smart Ways TO WORK

### Dining To Do the Deal

When you conduct business with a client over a meal, you want to create an atmosphere that puts you and your company in a very favorable light. The goal of the meal is to create an environment that helps make that client predisposed to buying your products, services or ideas. Unfortunately, an experience that should make that client amenable to your point of view, often times just does the opposite when they become so annoyed or appalled at nonexistent, or even rude manners. Ellen Kaye of Perfect Presentations, a Phoenix based organization that specializes in teaching business protocol and etiquette to many top executives of the leading corporations as well as coaching in the areas of communication, presen-

tation and image, shared some sad-to-say typical horror stories.

- A vice president of a major corporation was entertaining a client at lunch. This famished executive quickly downed his meal then noticed that his client seemed to be finished as well and had left a sizable portion of her cordon bleu. He looked over and asked, "you gonna eat that?" She shook her head no and looked on slightly stunned as he reached across with his fork and snatched the remains.
- A regional sales rep was entertaining an important client at a very nice Italian restaurant. The rep ordered his favorite, angel hair pasta with meat sauce. When the meal arrived, he took his napkin and stuck it under his chin like a bib. Perhaps not the most impressive display.
- An executive was at an awards event where a buffet was being served. Every time he went back to the buffet he placed his napkin on the table instead on in his chair. Each time he would return his place was cleared. After the third clearing he voiced his frustration to those at his table thus making his boss and colleagues aware that he didn't know that

you only place the napkin on the table when you're finished, which is the server's indication that you are done.

When you handle business over a meal your clients form opinions of you, both conscious and subconscious, by your behavior at those meals. A basic understanding of some business lunch do's and don'ts can go a long way to helping you create a more favorable environment for representing yourself, your company and your products. Here are some of Ellen's suggestions.

**Select A Restaurant Appropriate To Conducting Business.** When discussing business, you do not want to compete with noise and distracting activities in the restaurant. To be on the safe side, select restaurants where you have been before so you know what to expect. Nothing can kill a deal faster than the wrong atmosphere, loud music, a fashion show or a belly dancer.

**Reservations And Reserved Tables.** If possible, select a restaurant that takes reservations so you do not have to wait. Also try to reserve a table that has some privacy so your client can talk freely without the fear of being over heard. If papers need to be spread out, a standard table for two may be too small.

**Seat Selection.** You want to control the seating at your table. Place your guest with his or her back to the crowd so there are fewer distractions. This is just the opposite of how you would seat a guest in a social setting.

**Confer With The Server.** It would be advantageous to let your server know, prior to your guest arriving, that you are having an important business luncheon. You want the server to be attentive but not intrusive. Ask him or her to check regularly without disturbing the conversation. Tip your server in advance for the extra attention.

**Food Selection.** Of course let your guest order first. If your guest does not order alcohol you should refrain as well. Order a meal you can eat with minimal mess. This is not the best time for cracked crab, BBQ ribs or even artichokes. Avoid food items that may cause gas or a bloated feeling.

**Watch Your Manners.** Your napkin should be placed on your lap when you first sit down. When the food arrives, invite your guest to start by saying "bon appetite." Wait until your guest begins to eat before you do. Remember that once

# Access to Capital

## SBA Small Business Lending Momentum Continues in FY18

SBA FY18 total loan volume reaches more than \$30 billion with more than 72,000 approved loans

The U.S. Small Business Administration announced FY18 lending numbers showing that it guaranteed over \$30 billion to small businesses that otherwise would not have had access to capital.

“We are providing tools, resources and access to capital for America’s 30 million small businesses, and our FY18 numbers bear that out,” SBA Administrator Linda McMahon said. “SBA’s 7(a) and 504 loan programs have never been more dynamic, easy to use and accessible—helping small businesses succeed and thrive. Our loan programs in FY18 continue to show strong performance.”

In FY18 there were approximately 60,353 7(a) loans made, with a total dollar amount of \$25.37 billion. The 7(a) program is SBA’s flagship program, which offers guarantees on loans to small businesses of up to \$5 million on reasonable terms and conditions. 7(a) loans are commonly used for acquiring land, purchasing equipment, or working capital.

The SBA’s 504 loan program had another year of high performance for lending, with 5,874 loans made for a total dollar amount of over \$4.75 billion. In FY18 SBA launched the 25-year Deben-

ture, which offers an extra 60 months of financing at a fixed rate for small businesses. Since its introduction in April, over 1,000 debentures had been sold by the end of September.

“The 25-year Debenture is designed to help free up cash flow and offer fixed rates in a rising interest rate environment for 504 borrowers and we are pleased to see over \$1 billion has been disbursed in less than six months,” Associate Administrator for SBA’s Office of Capital Access William Manger said.

In FY18 there was significant growth in the SBA’s smaller loans, including a record volume of dollars lent in the Microloan and Community Advantage Programs. Specifically, over 5,000 loans were approved for over \$72 million in the Microloan program and over 1,000 loans for over \$150 million in SBA’s Community Advantage program.

The SBA continued to innovate and improve processes by leveraging enhanced technologies. Lender Match is an SBA technology platform that gives entrepreneurs the ability to complete a quick online form, without registration or cost, and be connected with an approved SBA lender within 48 hours. To date, Lender Match has gen-

erated 3.6 million leads on behalf of small businesses to our lenders and over 160,000 unique borrowers have been contacted by lenders with financing options.

Another technological innovation was the development of the SBA’s Franchise Directory, which was launched this year and has resulted in an over 50 percent increase in eligible franchise brands. There are currently 3,192 brands on the Franchise Directory. When the directory was first published in October 2017 there were only 2,034 brands. In FY18, SBA has seen a year over year increase of over 21 percent in 7(a) and 504 dollars going to franchises.

About the 7(a) and 504 loan programs

The 7(a) loan program is the SBA’s primary program for providing financial assistance to small businesses and offers guarantees on loans to small businesses of up to \$5 million on reasonable terms and conditions. 7(a) loans are commonly used for acquiring land, purchasing equipment, or working capital. The CDC/504 loan program helps small businesses acquire

fixed assets to promote economic development in the form of long-term fixed rate financing for fixed assets on reasonable terms. Under this program, the SBA authorizes CDCs (Certified Development Companies) to provide financing to small businesses with the help of third-party lenders (typically banks). The maximum loan amount is generally \$5 million; however, certain eligible energy-efficient or manufacturing projects may qualify for more than one 504 loan up to \$5.5 million each.

the new innovations; training; refinement of standards and specifications.

Some of the innovation areas include using innovative binders for asphalt, reclaimed asphalt pavement mixtures, reclaimed asphalt shingles for use with binders and mixtures; and on-site field investigations using nondestructive techniques.

“This is a highly competitive grant, one for which we had to compete, among others, with the incumbent institution,” Manos Maragakis, dean of the College of Engineering, said. “This award solidifies our program as the best pavement engineering program in the nation and one of the best in the world. I want to congratulate the faculty and the department for this major accomplishment, which also exemplifies the College’s commitment to excellence and national recognition.”

Hajj’s team includes project manager Adam Hand and senior researcher and PES program director Peter Sebaaly of the University’s pavement program; and from Applied Research Associates Harold Von Quintus (also co-principal investigator), Jennifer McCabe, Letha Cozart and Rodney Walker, marketing staff; and from

Paragon Technical Services, co-principal investigator Gaylon Baumgardner.

“We will be helping state highway agencies to accelerate implementation and deployment of innovations,” he said. “Engaging leaders within state highway agencies and industry groups is needed for successful product implementation and deployment.”
