The U.S. Small Business Administration's Office of Advocacy recently released an encouraging report on veteran-owned businesses. The report, which is based on the latest available data from the U.S. Census Bureau's 2012 Survey of Small Business Owners (released December 2015 and February 2016), shows about 2.52 million businesses in the U.S. majority-owned by veterans.

Almost all of these veteran-owned businesses at the time (99.9 percent) were small businesses

U.S Veteran Owned Business Statistics

According to the SBA report entitled "Veteran-Owned Businesses and Their Owners (PDF)," small business firms owned by veterans employed 5.03 million people, had an annual payroll of \$195 billion and receipts of \$1.14 trillion. The veteran-owned firms represented 9.1 percent of all U.S. businesses.

California, Texas and Florida had the most veteranowned businesses respectively, while the highest percent of veteran-owned businesses in their populations were found in South Carolina, New Hampshire and Virginia. Other highlights from the study include:

- Nearly 30 percent of all veteran-owned firms were in two industry groups: construction and the professional, scientific and technical services group.
- The industry with the largest share of veteran-owned firms was finance and insurance (13.2 percent), followed by transportation and warehousing (12.1 percent), and construction (11.4 percent).

helping black women become business owners. Since it was formed in 2012, the Build Institute has graduated nearly 600 students from its eightweek courses, which teach the basics of starting and running a business, including such topics as money management and how to determine your break-even point. Nearly 70% of those students are women, and 60% of them identify as a member of a minority group.

"Our typical participant is an African-American woman," said April Boyle, the group's executive director. "It was very intentional from the very beginning to be inclusive, because when we started we saw a gap. There was a lot of attention on high-scale, high-growth technology companies but not a lot of support for community and Main Street entrepreneurs. I'm now seeing this pipeline of people getting their feet wet with a bakery or craft entrepreneurship, and it's whetting their taste buds and really helping them to understand how to build companies and create wealth."

Danielle Smith launched Detroit Maid in 2013 after she couldn't find a cleaning service that was willing to take work assignments in Detroit. "Firms that were just two or three miles away in the suburbs wouldn't come into the city. It made me angry," she said. "And I was sure I wasn't the only Detroiter who wanted some kind of basic service.

So the self-described neat freak opened a cleaning service. Smith said it was scary going out on Image By: delightimages.com

her own after working in corporate America as a brand and marketing executive, but she derived strength from the Build Institute and her parents, who owned a pizza shop when she was growing up.

"My brothers and I did everything from bus tables to pour coffee," Smith said. "I learned a lot about entrepreneurs: the good stuff, the bad stuff, the ugly stuff."

For its part, the Build Institute taught Smith the "technical stuff" and gave her advice on how to market and brand her services, including creating a special 40-point checklist she calls the "maid-ifesto" to help customers understand what goes into a basic cleaning. Making that simple and understandable has helped with clients, she said.

Smith's first customer was Paramount Pictures, which was in Detroit filming Transformers: Age of Extinction. The company found her through a Google search and asked Smith to put together a proposal. She did and got the contract. Since then, she has hired four part-time employees and has worked on nearly 300 accounts, both commercial and residential, and is looking at revenue of ap proximately \$80,000 in 2015, more than double last vear.

Smith is unusual among entrepreneurs of any race or gender in that she employs more than just herself. Just 10% of women-owned businesses, and approximately 20% of men-owned firms, have employees. Firms owned by women employ just Continued on page 8

California's Tourism Industry Sets Records In 2016

Industry fuels the state's economy as it experiences seventh straight year of growth



Traveler spending in 2016 injected a record \$126 billion into the Golden State's economy, Visit California announced today as the industry marked the first-ever California Tourism Month. Oakland is quietly taking a growing share of Bay Area business

While San Francisco rightly attracts attention for its role in cultivating fast-growing businesses, Oakland is building a community of entrepreneurs happy to be out of the limelight.

Since the likes of Hewlett Packard began the Silicon Valley trend back in the 1940s, Northern California has become a hotbed for enterprise talent and explosive business growth.

No city has become more synonymous with technology, venture capital and billion-dollar valuations than San Francisco. However, on the other side the bay, Oakland is developing a burgeoning business district populated in equal measure by people tired of the surging cost of living and those looking to grow under the radar.

During a trip to the Bay Area in February, Real Business was able to meet some local businesses

first hand and find out what the unique characteristics of the area are - and why owners feel there has never been a better time to pick Oakland over San Francisco.

While the likes of Uber and Pandora are examples of billion-dollar businesses with a footprint in the city, clothing brand Oaklandish is an SME that has its roots in the area – and is pretty proud of that.

Milton Williams, community coordinator at the company, sat down with us at the brand's downtown shop to answer some questions.

"Oakland has inspired Oaklandish since day one," Williams said. "Oaklandish started in 2000 as a grassroots art project dedicated to showcasing individuals and movements that originated within city limits. As Oaklandish has evolved, so have our products, but that original tribute to the city's legacy remains. Simply put, Oaklandish could not happen anywhere else but Oakland." One trend that kept cropping up as our group travelled around Oakland, as part of a trip with Norwegian Airlines, was the strong sense of community that exists in the area.

In fact, research conducted in 2013 found that the city was the most diverse in the US with a population of more than 400,000 – beating out the likes of Sacramento, New York and Chicago, which also scored well.

"Oakland is one of the most diverse cities in the US, and that diversity is reflected in our employees. We bring a great variety of viewpoints together, and that creates a company that is always ready to experiment and innovate while bringing all our varying skills to the effort. Also, we get 260 sunny days a year, so that makes for happy coworkers," Williams went on to say.

6 Solid Tips for Veterans in Need of a Loan

U.S. military members transitioning out of service can find themselves facing many unique money challenges. After all, duty to one's country can understandably push personal money management to the back burner. Fortunately, there are steps veterans can take to secure the funding they need to achieve their financial goals.

Here are some tips for veterans looking to secure a mortgage, small business loan or other types of financing.

1. Know What Federal Benefits Are Available

There are programs out there designed to help veterans and their families overcome the various money challenges that can arise when a family member is on active duty. For instance, veterans are eligible for VA home loans, which often feature no down payment, no mortgage insurance and flexible underwriting requirements. And there are various grants, loans and business development programs backed by the U.S. Small Business Administration that can help former military members and budding entrepreneurs.

Veterans can get acquainted with the general benefits available to them on the Veterans Benefits Administration website. Prospective entrepreneurs can begin looking into business financing by checking out the Small Business Administration's Office of Veterans Business Development online.

2. Research All of Your Options

That's not to say veterans should limit themselves to federal loan programs. For instance, when it comes to mortgages, "to be sure, VA loans aren't the right fit for every veteran," Chris Birk, a Credit.com contributor and director of education for Veterans United, a VA loan lender, said. "Understanding all of your mortgage options is also key to getting the best deal possible. Even veterans with sterling credit and a 20% down payment would benefit from comparison shopping between conventional and VA loans."

3. Consider Financial Institutions That Cater to Vet

If you do decide to go for a VA loan to buy a home, consider finding a mortgage lender who knows the ins and outs of that type of financing.

"VA loan market share has soared over the last decade, but it's still a niche product for many lenders and real estate professionals," Birk said. "Working with companies and professionals who know the ins and outs of VA loans can help ensure veterans get the most from this benefit."

Similarly, you can look into finding a credit card issuer or bank that caters to former and current military members. (We've got a list of some of the better military credit cards here to help you get you started on your search.)

And there are several startups, venture capitalist funds and, even, angel investors out there that offer small business financing exclusively to veterans and military members that may prove worthwhile, depending on your financial situation.

4. But Be Sure to Assess Your Finances Holistically

We say "depending on your financial situation" because it's important to consider factors beyond your status as a veteran when making money decisions. Take credit cards as an example. Ultimately, the right one for you will be influenced by your current financial situation or goals. For instance, if you're trying to pay a lot of debt, you might want to look into a balance-transfer credit card.

The same thing applies when exploring other financing opportunities — just because you're a veteran doesn't mean products designed for veter-



ans are going to be the ones that best need your financing needs.

5. Watch Out for Scams

Due to the money challenges some veterans face (often related to spending extended periods of time out of the country or relocating frequently), they often find themselves on a scammer's radar. That's why it's a good idea to vet any business you're thinking of getting a loan from before filling out applications. You can start by conducting a thorough search online or checking a company's status with the Better Business Bureau.

6. Brush Up Your Credit

A good credit score can make all types of financing more affordable, so it's a good idea to see where you stand before applying for a loan. You can get a free credit report snapshot, along with two free credit scores, updated every 14 days, on Credit. com. You can also pull your free credit reports from each of the major consumer credit reporting agencies each year at AnnualCreditReport.com.

If you need to build credit, you can look into credit-builder loans or secured credit cards, which help people with thin files establish a history of using credit wisely. If you need to improve your credit, you can focus on paying down high credit card balances, disputing credit report errors and limiting applications for new credit, all of which can hurt your credit score.

5 Tips to Improve Your Odds of Getting a Small Business Loan

In a perfect world, every entrepreneur would have the resources necessary to transform a killer business idea into a smashing success. However, as you know by now, that's not how it works.

In fact, having a great idea is only part of the equation: At some point, most entrepreneurs need a small business loan. Unfortunately, however, getting approved for a loan can be challenging if you don't have all of your proverbial ducks in a row.

Five tips for getting approved

When it comes to getting a small business loan, you have to put yourself in the shoes of the bank or financial institution that you're interacting with. If you were in their role, would you feel confident loaning money based on the set of circumstances and factors an applicant provided, and the interview process? Once you flip the script and look at things from their perspective, you should be able to see your situation in a less biased light.

That being said, here are a few tips for getting approved.

1. Start the process asap.

You aren't going to walk into your local bank, fill out an application, and get approved for a loan on the spot. The approval process can take weeks, if not months to unfold. That's why it's best to start the process as soon as you can. Don't wait until you need the money or you may end up with your back against the wall.

2. Deal with your credit history.

While you may desire separation between your business and personal finances, lenders will factor in your personal credit history when determining your risk level as a borrower -- there's simply no way around it.

If you're worried about this part of the process, focus on some ways to improve your credit score. According to Credit Sesame, your credit score is made up of the following five factors: payment history (35 percent), credit utilization (30 percent), credit age (15 percent), account mix (10 percent) and credit inquiries (10 percent).

As you can see, payment history and credit utilization make up the bulk of your score. By paying bills on time and using less of your approved credit line, you can bump your score up a few points in a matter of months. Realistically, you're going to have trouble getting a small business loan from a traditional lender if you have a score of 660 or lower. Ideally, lenders want to see a score of 720 or higher.

3. Have a detailed plan for using the money.

When speaking with a lender, be very clear about how the money will be used. Giving some vague or general response about growing your business isn't going to work. The lender will want to know exactly how the money will be used in order to determine the feasibility of your application.

Every business is different, but a few of the smartest ways to use a loan include an inventory purchase, business expansion, administrative expenses and capital investments. You may also choose to refinance or pay down debts, but lenders won't always look at these uses with high regard.

4. Be organized and over-prepared.

Organization plays a key role in whether or not you'll be approved for a small business loan. If the lender asks for a specific piece of information, you need to be capable of providing it in a timely manner. A lack of organization shows that you're unprepared and risky. The best thing you can do is over-prepare ahead of time. By having ready every possible piece of information or documentation that your lender could want, you can wow him or her with your efficiency, and take control of the process.

5. Get advice from experts.

Asking a lender for \$100,000 to grow your business is one thing. But totally different is setting up a meeting and explaining that you've met with your financial advisor, accountant and board of directors, who have determined that you need \$103,000 to expand your production facility and lower your cost of goods sold.

As mentioned, lenders want to see a specific plan. They also want to know that you aren't acting alone. They like to see that you're communicating with experts in your field and fully understand the situation. **Improve your odds.**

Getting approved for a small business loan is no easy feat. The burden of proof is on you to convince the lender that you're worth the risk associated with lending money. Put yourself in these people's shoes and think about how you look.

• Five industry groups accounted for 71.5 percent of all veteran-owned firm sales: wholesale trade (22.9 percent), retail trade (19.5 percent), manufacturing (12.3 percent), construction (10.1 percent), and professional, scientific, and technical services (7.0 percent).

Also, a bigger percentage of veteran-owned businesses were home-based (57.0 percent) compared with other businesses (52.2 percent) in the rest of the population. And the most common method for veterans to become business owners was to start their own businesses themselves.

It's encouraging to see military veterans take advantage of entrepreneurship opportunities available to them, and to continue to display many of the same qualities and resilience of civilian entrepreneurs. If you are a military veteran who owns a small business or you know some vets, there are many sources of support for veterans, including the SBA's "Boots to Business" Program. These resources offer varied resources from franchise opportunities to business loans that help combat unemployment among returning veterans, and also demonstrate appreciation to our veterans for their service.

"Entrepreneurship is a choice made by many of our men and women in uniform when they move into civilian life," said Dr. Winslow Sargeant, former Chief Counsel for Advocacy for the SBA, in a previous statement about a similar SBA study. "Knowing more about the factors behind veterans' self-employment offers opportunities to lay the groundwork for successful ventures."
